Business:

- **1. Approval of Minutes -** Minutes were approved without modification upon the motion of Commissioner Shipman and the second of Commissioner White.
- 2. Budget Report—received and approved.
- **3. Presentation for Park equipment** The commission received a presentation by Jamie Carter of Bliss Products on playground equipment options, trail benches, bike lock stations and refuse receptacles. Enhancements options for the dog agility park were also explored. Swings and climbing wall options were of particular interest.

Discussion of potential timing of trail creation and pricing for trail benches, refuse receptacles and bike locks was conducted.

- **4.** Eagle Scout project Upon the motion of Commissioner Shipman and the second of Commissioner Clark, the commission approved the Eagle Scout Product trial improvement proposal attached to the commission agenda.
- **5. Consideration of by-laws** By unanimous consent the commission considered adoption of by-laws, loosely patterned after those of the town's planning commission. After amendment of the proposed by-laws to replace planning commission references, the by-laws were approved with modification upon the motion of Commissioner White and the second of Chairman Van Vleet.
