Hunting is prohibited

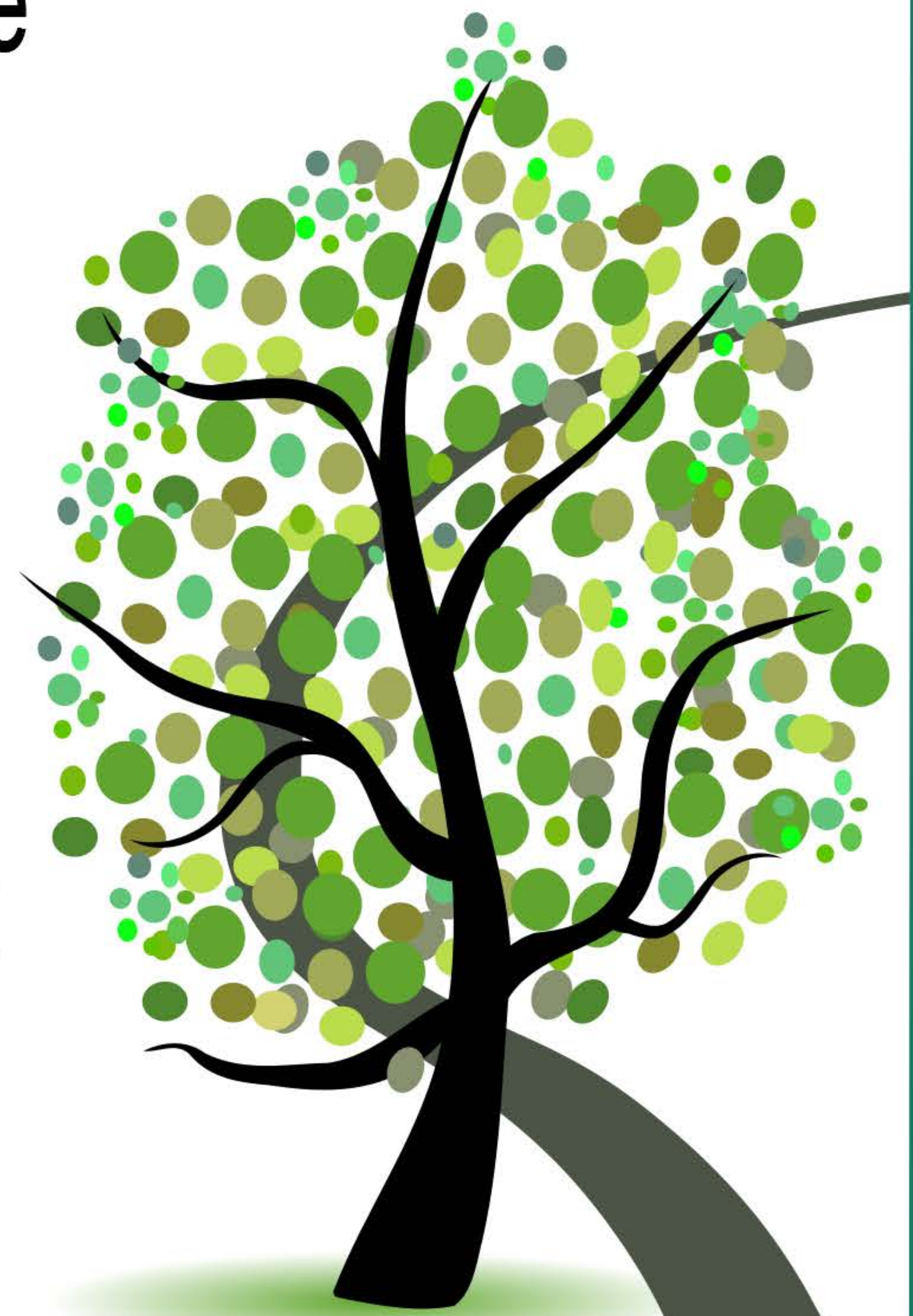
Litter must be carried out of the park
